

Privacy & KVKK Notice

Effective date: 19 July 2026

This notice explains how Ceneviz Sanat, as data controller, processes personal data when you visit cenevizsanat.com, under Turkish Personal Data Protection Law no. 6698 ("KVKK"). The Turkish version prevails in case of any discrepancy.

1. Data Controller

2. Personal Data Processed

- Technical data: IP address, browser and device information, screen size, language preference.
- Usage data: sections viewed, panel movements, link clicks, image views.
- If you contact us by email or WhatsApp, the contact details and message you send.

The site has no forms; unless you contact us, no name or contact details are collected.

3. Purposes

- Producing statistics about how the site is used, and improving its content.
- Measuring how effectively our event announcements reach people.
- Answering the questions and requests you send us.

4. Legal Basis

Visit statistics are processed on the basis of our legitimate interest under KVKK art. 5/2-f, provided this does not harm your fundamental rights and freedoms. The measurement tool we use sets no cookies in your browser, processes data in pseudonymised form and is hosted by us — so no consent is required and the site shows no cookie prompt. Requests you send us directly are processed for the establishment of a right and to fulfil your request.

5. Third Parties and Transfers Abroad

Visit statistics remain on our own infrastructure and are not shared with third parties for advertising or marketing.

However, the embedded Google Maps map in the Info section and the fonts used on the page are loaded from Google's servers. During those requests your IP address and browser information are disclosed to Google, and that transfer takes place abroad. If you prefer not to load the map, the address is also available as plain text on the page.

Instagram images are served from our own server; viewing the page sends no request to Instagram.

6. Ticket Purchases

Ticket sales are handled at bilet.cenevizsanat.com. Personal data processed during a ticket purchase is covered by the separate notice published on that site.

7. Retention

Visit records are kept for statistical purposes for a reasonable period and contain nothing that directly identifies you. Messages you send us are deleted within a reasonable period after your request has been dealt with.

8. Your Rights

Under KVKK art. 11 you have the right to learn whether your personal data is processed; to request information if it has been; to learn the purpose of processing and whether the data is used accordingly; to know the third parties to whom it is transferred at home or abroad; to

request correction if it is incomplete or incorrect; to request erasure or destruction in accordance with the legislation; to request that such actions be notified to third parties to whom the data was transferred; and to object to a result against you arising from analysis solely by automated systems.
